A message from our Artistic Director

CONGRATULATIONS DANCERS!

THANK YOU FOR YOUR PERFORMANCES AND PARTICIPATION IN OUR NUTCRACKER FILM

Think back, way back to mid-March. We had no idea that the pandemic would change our lives so substantially and for so long. We figured out how to teach and take ballet class over the internet. We outfitted The Studio with 140-foot ethernet cables and bigscreen TVs. We improvised and built home studios with portable barres and flooring. We uploaded the Zoom app and purchased accounts. The Studio received a PPP loan, enabling me to retain instructors and staff. We did our best to maintain normalcy and consistency through the summer. However ... quickly it became clear that assembling an audience in 2020 was probably not going to happen. Now what?

What followed felt like a whirlwind. I enlisted the help and talents of our alumni Dream Team: Georgina Wilson, Alicia Houser and Flora Chatwin. We decided not to open Nutcracker auditions to the public and only offer the opportunity to our own students. We auditioned dancers 2 at a time, over the course of 4 days. We rehearsed in small groups and in the parking lot of Hope Church and even over Zoom. We filmed the entire production in 5 days mid-October. What normally takes the entire fall was condensed into a few short weeks. The project kept our dancers learning new choreography, practicing their skills, and in the filming process, it kept them literally on their toes and able to improvise within unusual conditions. Our dancers' performances were uniformly incredible. They danced on all manner of surfaces, socially-distanced at the film sites and changed into costumes like surfers with towels. In the editing process, much of the footage was left on the cutting room floor to keep continuity in the story. But ALL of our dancers performed beautifully and each and every one of you is integral to the success of the project. The movie kept our dancers focused, learning, growing, motivated, empowered, striving, and doing something most of us have never done before.

Your hard work and individual growth during a new process are what are most important. I hope you enjoyed the journey and I congratulate you on your contributions through resilience and commitment. I am very proud of each and every one of you!

BALLET ALLIANCE EVENTS AND EMERGING CHOREOGRAPHIES

In January The Ballet Alliance will provide a webinar about Dancer Mental Health led by counselors Josh Spell and Rachel Coats, both former ballet dancers. We appreciate the opportunity to learn about this important subject.

Next up on The Ballet Alliance series of events is company Adjudications, which will be virtual for SCBT. A professional from the field will watch a company class – at home on zoom or in the studio, however things progress — and will give feedback/encouragement on our training methods. Normally this event would include presentation of pieces, but with our companies all in different stages of Covid protocol, TBA decided not to include that aspect of the evaluation.

Meanwhile, our seven emerging choreographers are hard at work creating new pieces with their peers. These pieces will be filmed and shown to our expert panel: Linda Lock, Nicole Comella (AD of State Street Ballet Young Dancers) and either Debra Rogo or David Arce (AD and Associate AD of Mid-Columbia Ballet, respectively). The panel will offer feedback, and from there the strongest pieces will be presented to The Ballet Alliance panel, who will give awards and scholarships. The Ballet Alliance will present an Emerging Choreographers' Showcase this spring.

TBA will provide master classes to our dancers as the final installment of Festival Mosaic this season.
